

Vistry Conversational AI Platform - Terms of Service

Effective Date: October 1, 2023

Please read these Terms of Service ("Terms") carefully before using Vistry's Conversational Al Platform for Food Commerce. These Terms govern your access to and use of the LumoChat and ZenoChat chatbots provided by Vistry. By using our platform, you agree to comply with these Terms. If you do not agree to these Terms, please do not use our platform.

1. Definitions
